

# Pet Occupancy Agreement

The Crystal Inn Hotel & Suites welcomes pets, specifically domestic cats and/or domestic dogs, in specified guest rooms. Please read the following rules set to guarantee a delightful stay for all guests, animal and human alike.

1. I fully understand and agree, Crystal Inn Hotel & Suites accepts no responsibility of liability for the loss, injury, health, illness, death, or change in appearance of any pet kept in the guest room, on or in the vicinity owned or operated by Crystal Inn Hotel & Suites, its staff, or agents.
2. I accept without reservation, full and total responsibility and liability for any and all injuries, damages, accidents, or incidents which might be caused by my pet, be it to persons or property of Crystal Inn Hotel & Suites, its guests, clients, vendors, or other transient persons on or in the vicinity of the hotel.
3. I agree to hold harmless Crystal Inn Hotel & Suites, any person employed by them or their agents from any legal action or suit regarding my pet, my pet's actions or behavior, whatever its reason or origin.
4. I agree that my pet(s) will not be left unattended in any guest room, common area, motor vehicle, or any part of the property of Crystal Inn Hotel & Suites unless otherwise approved by the General Manager of the Crystal Inn Hotel & Suites. I acknowledge that if my pet is left in my guest room unattended with approval, it must be left in a crate or pet carrier and I will not receive housekeeping service. I further understand I may be held responsible for noise complaint refunds and I may be evicted from the hotel for damages related to my pet being left unattended and my failure to answer my cell phone.
5. I agree that my pet(s) will be kept on a leash at all times while out of the room. I will not take my pet into the public areas (such as the lobby, breakfast area, pool, or workout facilities) at any time.
6. I fully understand and agree that I will be responsible at all times for keeping my pet quiet and orderly. I understand that if, in the judgment of the management of Crystal Inn Hotel & Suites, I have failed to keep my pet quiet and orderly, I will be required to remove the pet from the hotel property, without regard to the hour of the day. I fully understand and agree that the failure to remove my pet on request of Crystal Inn Hotel & Suites management will constitute grounds for eviction from the hotel, without regard to the hour of the day.
7. I fully understand and agree that I will be responsible for cleaning up droppings after my pet(s). I have been notified that bags are available at the front desk if needed. I agree that I may incur additional fees if I do not clean up after my pet(s).
8. I agree that I will have no more than 2 pets per room and my pet(s) is less than 25 lbs unless otherwise approved by management of the Crystal Inn Hotel & Suites.
9. I fully understand and agree that this policy is subject to change at the discretion of the Management of Crystal Inn Hotel & Suites.

I agree to pay a non-refundable pet fee in the amount of \$50.00 per reservation for one pet and \$100.00 for two pets. I agree to pay \$100.00 per reservation for one pet and \$200.00 for two pets if my stay is to exceed 7 nights. I agree that this fee is for basic deep cleaning only and I may incur additional fees should any damages occur or additional cleaning be required in conjunction with my pet.

I acknowledge that I have read, on behalf of myself and all members of my party, and do fully understand and agree to all stipulations and specifications of the above Agreement regarding the physical presence and housing of my pet at the Crystal Inn Hotel & Suites.
